BACKGROUND



Project Walkthrough

- Mangere – Trial Feb 2003 (4 weeks) and then fully implemented and funded from Dec 04 – March 05
 - Lower Hutt – 2005
 - Manukau City (Mangere, Papatoetoe, Otara, Wiri, Manukau and Manurewa) – Dec 05 – March 06
- Supporting Maori Wardens with information, resources and training to monitor licensed premises in Manukau City.



PROJECT GOAL

**To reduce alcohol related harm in
Manukau City**



PROJECT PURPOSE

- **To utilise the Maori Wardens to monitor the compliance of the Sale of Liquor Act and Liquor Ban Bylaws by licensed premises and the general public.**
- **To report any breaches of the above to the District Licensing Agency (DLA) and Police.**
- **To increase the perception of local safety amongst licensed premises, their staff and patrons.**

**For the purpose of this project,
we utilised the power of entry ONLY under the
Maori Community Development Act 1962.**

2004 - 2005

- **Pilot Project successfully implemented and independently evaluated in Mangere (Dec 04 – March 05)**
- **Project successfully implemented in Lower Hutt (2005 - 2006)**

2005 - 2006

- **Project implemented in Manukau City (Dec 05 – March 06).
Still to be evaluated, but initial results are positive.**
- **Currently being scoped for implementation in the Wairarapa**

THE FACTS



- 3 month period Dec 05 – March 06
- Mangere, Otara, Papatoetoe, Wiri, Manukau and Manurewa
- Times: 6pm – 2am
- Thurs, Fri and Sat nights
- 16-24 hours work per week by Wardens
- Monitored up to 45 premises and liquor ban areas each night – (480kms covered each week)
- Weekly meetings with Project Manager, Coordinators, Team leaders and Steering group
- Fortnightly Intel (Police) and DLA meetings

THE FINDINGS

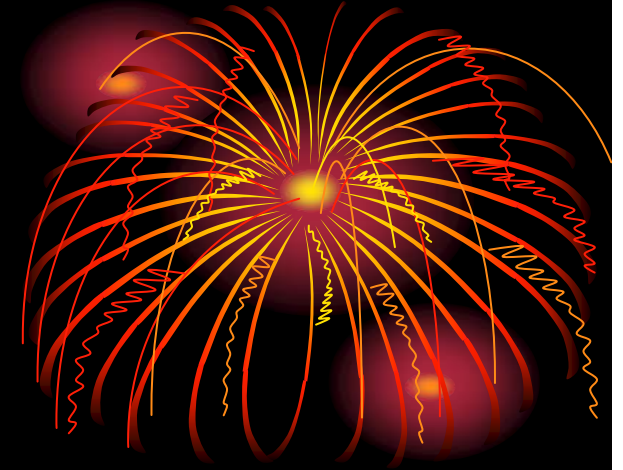
Any incidents that occurred were either reported immediately to the Police and a report sent to the DLA on the Monday following the Walkthrough.

Incidents covered the following:

- 1. No Manager on site**
- 2. No SOLA license displayed**
- 3. Uncooperative Managers & staff**
- 4. Underage drinking**
- 5. Evidence of drinking in Liquor ban areas**
- 6. Intoxicated patrons**
- 7. Urinating in public area**
- 8. Children left in cars outside premises**
- 9. Drinking in carpark**
- 10. Disorderly behaviour**
- 11. Fighting**
